Please note: Internal make good has not included colour matching paint. Make good has been patched, sealed and primed in white. Minor issues raised after this inspection may not be addressed, as Preservation Technologies will not return for late or minor rectification items.

### **Liability Period**

The works are covered by a 12-month defects liability period. If any major issues arise during this time (e.g., repairs fail), please notify the Strata Committee. The committee in consultation will assess the matter and decide on the appropriate action. Their decision will be final.
